## FIRST AMENDED HOMES ASSOCIATION DECLARATION TO HAMPTON PARK (the "Declaration")

THIS FIRST AMENDMENT TO THE HOMES ASSOCIATION DECLARATION OF HAMPTON PARK (the "Declaration"), is made this 24 day of May, \_\_\_\_\_, 1995, by HAMPTON PARK VENTURE, a Kansas general partnership (hereinafter referred to as "Developer").

## WITNESSETH:

WHEREAS, the Homes Association Declaration to Hampton Park (the "Declaration") was executed on October 25, 1994, and filed with the Register of Deeds of Johnson County, Kansas, at Page 315, Volume 4465 and file-stamped on November 7, 1994.

WHEREAS, the Developer wishes to amend that certain Homes Association Declaration recorded at Volume 4465, Page 315, with the Register of Deeds of Johnson County, Kansas.

NOW, THEREFORE, the Developer makes the following amendments:

1. Section 7, beginning on Page 4 and continuing to Page 6, shall have the following paragraph added as a new subparagraph (o), to read as follows:

(0) <u>Maintenance and Care of Backyards on Lots 44 through 59,</u> <u>73, 74 and 75</u>. To provide for the maintenance and care of the area between the perimeter fence and the curb on 124th Street and Grant Street, as contained in the subdivision. This provision shall be applicable to backyards only and shall not apply to any side yards.

2. The remaining terms, conditions and provisions of the Homes Association Declaration to Hampton Park (the "Declaration") as filed at Page 315, Volume 4465 is hereby ratified, approved and reconfirmed.


